Kumoricon 2021 Art Show Contract

All fields must be completed.

Artist assumes entire responsibility and hereby agrees to protect, indemnify, defend, save, and hold harmless Altonimbus Entertainment (ANE), Kumoricon, and their agents, and the Oregon Convention Center and their employees and agents, against all claims, losses, and damages to persons and property, governmental charges or fines, and attorney's fees arising out of or caused during the mailing, installation, removal, maintenance, or part thereof, excluding any such liability caused by the sole negligence of ANE, Kumoricon, or the Oregon Convention Center.

Kumoricon's Chair has final authority for determining whether the artwork complies with Art Show requirements, including cases of suspected plagiarism, trademark or copyright infringement, or violations of any applicable policies.

In addition, Artist acknowledges that ANE, Kumoricon, and the Oregon Convention Center do not maintain insurance covering the artist's property or liability. It is the sole responsibility of the artist to obtain any desired insurance for property damage, liability, or business interruption covering any and all losses by Artist.

If Artist does not pick up their unsold artwork by November 7, 2021, 4:00 pm, and has not provided a return mailing address and payment for shipping expenses by November 11, 2021, then ownership of the unsold artwork pieces will transfer to Altonimbus Entertainment.

This agreement is not a grant of reproduction rights with the sale of Artist's work.
